COMPLAINT AND JURY DEMAND

(Tier 3)

Plaintiff Timothy Ballard makes the following allegations:

PARTIES, JURISDICTION, AND VENUE

1. Plaintiff Timothy Ballard (“Plaintiff” or “Mr. Ballard”), is an individual residing in Utah County, Utah. He is the founder of Operation Underground Railroad (“OUR”). He has

been involved in undercover investigative operations which have helped rescue many women and children from the horrible and dark world of sex trafficking.

2. Defendant Amy Morgan Davis (“Defendant” or “Ms. Davis”) is an individual and on information and belief resides in Davis County or Utah County, Utah. She appears to have been the winner of the Miss Utah pageant in 2004.

3. This Court has jurisdiction pursuant to Utah Code §§ 78A-5-102 and 78B-6-401 *et seq.*

4. Venue is proper in this county pursuant to Utah Code §78B-3a-201(1)(a)&(b).

FACTUAL ALLEGATIONS

5. Mr. Ballard incorporates the previous allegations by reference.

6. Mr. Ballard reluctantly brings this suit after having waited for nearly a full year for Ms. Davis to withdraw her false claims against Mr. Ballard and come forward with the truth. Rather than doing so, Ms. Davis doubled down recently by giving an interview to the New York Times, and other media outlets, falsely stating that she was sexually assaulted by Mr. Ballard. The false claims have to stop, and this lawsuit is intended to begin putting a stop to them. It is likely that Mr. Ballard will soon be filing similar lawsuits against other false accusers.

7. OUR conducted a formal training starting October 14, 2021 and continuing throughout that weekend. Ms. Davis was invited to attend, at OUR’s expense, and agreed to do so. She was under consideration as a possible undercover operator for OUR.

8. Unfortunately, it appears Ms. Davis was not there for the OUR training, but rather with hopes of seducing Mr. Ballard.

9. On or about the evening of October 14, 2021, participants in the training were expected to check in at the hotel conference room where the training was to be conducted. Ms.

Davis never did so. Mr. Ballard and another member of OUR's staff stopped by her room to have her sign the necessary check-in paperwork, and she confirmed she would attend training the next morning.

10. On or about October 15, 2021, the first day of training took place. Ms. Davis never showed up, despite having used her hotel room and accommodations at OUR's expense.

11. On or about the morning of October 16, 2021, Mr. Ballard stopped by the room of Ms. Davis to ask why she did not show up for training the prior day, and whether she intended to attend going forward. Ms. Davis had no good explanation for her lack of attendance, other than to claim she had been practicing on her own, and she spontaneously began "demonstrating" her purported skills for Mr. Ballard. Her "demonstration" soon became obviously personal, and as soon as Mr. Ballard understood Ms. Davis was attempting to seduce him, he rejected the attempt, separated from Ms. Davis and went down to the training conference room.

12. Upon his arrival at the training conference room, Mr. Ballard reported the incident to an OUR staff member. Mr. Ballard then took a seat at the training, and within approximately one hour Ms. Davis showed up to the training, and immediately approached Mr. Ballard. She whispered into Mr. Ballard's ear, "come to my hotel room tonight," and walked away. A witness saw Mr. Ballard react to the whisper, and Mr. Ballard told him what was said. Mr. Ballard then reported the situation to two other staff members, and asked that Ms. Davis be removed from the training, as her behavior disqualified her for further consideration.

13. Other than her brief appearance on or about the morning of October 16, 2021, Ms. Davis never attended the training, and was asked to leave thereafter in a friendly, non-confrontative manner. She confirms that she never saw Mr. Ballard after the October 2021 event.

14. Based on more recent statements made publicly by Ms. Davis, she now falsely claims there was no actual training by OUR at that time. Evidence is abundant to show that OUR indeed conducted training with many participants that weekend. Ms. Davis was well aware that there was real training being conducted, but failed to attend despite taking full advantage of the accommodations paid for her by OUR. She also falsely claims now that she was sexually assaulted by Mr. Ballard during the time of the training. Evidence is abundant to show this claim is also false.

15. Shortly after the training, Mr. Ballard sent Ms. Davis a friendly text, hoping to calm any feeling she may have developed of being scorned by him and/or OUR.

16. On November 11, 2021, Mr. Ballard acknowledged to OUR's Matt Cooper that he sent a message to Amy, and explained he did so "to calm any waters with her . . . to soften the blow. In case she starts feeling scorned or something." He reconfirmed to Mr. Cooper that "She disqualified herself when she tried to violate the policies in place so openly."

17. On November 22, 2021, Ms. Davis began texting Mr. Ballard, expressing disappointment that she was not able to complete the training and potentially go on undercover operations with Mr. Ballard.

18. Although she now publicly claims she was assaulted by Mr. Ballard during the October 2021 training, and that Mr. Ballard supposedly made her feel "very uncomfortable," her contemporaneous November 2021 and later texts tell a much different story. In her November 2021 text messages, she stated, among other things:

- a. "I'm sad we can't train together."
- b. "I felt really comfortable with you."
- c. "Hopefully the decision wasn't because of me."

- d. "I really respect and admire you and loved our connection."
- e. "I trust you and felt like we were a good fit."
- f. "... maybe we can talk in person?"
- g. "I'm sad I can't see you."
- h. "Maybe your eyes cast a spell on me lol"
- i. "Baby blues"

19. Mr. Ballard's responses remained consistently warm and unaccusing, still hoping to "calm any waters with her," and to avoid having her feel scorned. Attached hereto as Exhibit 1 are the actual text messages; the first batch between Mr. Cooper and Mr. Ballard; and the remaining texts between Ms. Davis and Mr. Ballard, which were preserved via forensic imaging.

20. There are other written communications and third party witnesses that confirm Ms. Davis was removed from the training due to her highly inappropriate conduct towards Mr. Ballard. Ms. Davis was never invited back again, and was no longer considered a potential operator for OUR. Mr. Ballard and OUR treated Ms. Davis kindly and gently when removing her from the event, and did not escalate things by aggressively telling her she was being rejected or why. Nonetheless, she was indeed rejected from the program for such reasons, and there are multiple forms of evidence to confirm that.

21. Seven months after the training event, in June and July, 2022, Ms. Davis again reached out to Mr. Ballard, asking him to help her get hired to perform for the Freedom Festival, and sharing links with him of performances she had recorded and which were available for viewing on social media. She added, "Just keep me in mind if you need anything."

22. At some point in the summer or fall of 2023, on information and belief, Ms. Davis, in collusion with others, secretly stated to leaders of the Church of Jesus Christ of Latter-

Day Saints and to members of the media that Mr. Ballard had sexually assaulted her. Plaintiff is not currently able to verify this allegation as the statements were made anonymously, so these facts will need to be determined through discovery.

23. On or about September 28, 2023, attorney Suzette Rasmussen held a press conference on behalf of an unspecified number of anonymous women, in which she claimed to be reading a statement on behalf of the women, which, on information and belief, included Ms. Davis. In the press conference, Ms. Rasmussen claimed the women she represents are affirming they were subjected by Mr. Ballard to “sexual harassment, spiritual manipulation, grooming, [and] sexual misconduct.”

24. On or about October 9, 2023, two years after her last meeting with Mr. Ballard, and nearly two years after her November 2021 text messages with Mr. Ballard, Ms. Davis filed a civil complaint against Mr. Ballard. She did so anonymously, without disclosing her identity. In the civil complaint, Ms. Davis submitted a personal statement, which, she claimed through her attorney in a press release, “sets forth in painful detail” her interactions with Mr. Ballard.

25. This complaint was not only filed in court, but was also attached to a “Press Release” dated September 9, 2023 (which appears to be a typo and should say October 9, 2023), with contact information for Attorney Ms. Rasmussen and a statement indicating “Today, five women filed a lawsuit . . . against Tim Ballard The complaint accompanies this Press Release.” It further states “Each of the five women provided their own statement that sets forth in painful detail how Tim Ballard manipulated and sexually assaulted them, under the guise of fighting childhood trafficking. . . . These five brave women . . . want the world to know the truth.” They claim Mr. Ballard is “a sexual predator,” and that “Tim Ballard literally trafficked them for his own sexual and egotistical gratification”

26. In her personal statement which was published widely via the press release, Ms. Davis claimed:

- a. she “met Tim at my hotel room . . . where I did another audition to see if I was eligible. . . . [H]e said to show me what I was willing to do or how far I was willing to go without physical contact. . . . [H]e told me to say “F#%* me” as I looked in his eyes.”
- b. “I felt very uncomfortable” (wholly contradictory to her extemporaneous text messages in November 2021 proclaiming she was “really comfortable” with Mr. Ballard).
- c. “After a long while and with his arms around me he said he was too turned on and that we should go to the gym together I declined. I never saw him again and he later told me he couldn’t do missions any more”
- d. “I was told the next day to go to training but there wasn’t any training to go to.”

27. In her complaint which was published widely via the press release, she claimed, among other things:

- a. “Ballard participated in several sexual acts with the exception of actual penetration, in various states of undress while on an OPS mission.”
- b. Mr. Ballard “committed battery and sexual assault” on her.
- c. Mr. Ballard “made fraudulent statements” to her, including that “the COUPLES RUSE . . . helps in fighting human trafficking,” which statements she claims are “false.”

28. Defendant caused the above statements to be disseminated to the press. Multiple media outlets published the statements on October 9, 2023 and thereafter.

29. Ms. Davis remained anonymous when she filed an amended complaint in November 2023, and a further amended complaint in April 2024.

30. Recently, however, she revealed her identity and gave an interview to the New York Times, and potentially other media outlets. In the New York Times article, Ms. Davis is reported to have claimed Mr. Ballard “made escalating sexual advances that included caressing her body with his hands.” The New York Times article was picked up by other media outlets, including People Magazine, which reported with the headline “Former Miss Utah and Other Women Accuse Prominent Human Trafficking Advocate of Harassment and Abuse: Reports,” and noted Ms. Davis sued Mr. Ballard “for sexual assault.”

FIRST CAUSE OF ACTION
(Defamation)

31. Plaintiff incorporates herein all prior allegations as if fully set forth herein.

32. Ms. Davis published all of the statements set forth above, including, but not limited to:

- a. Mr. Ballard sexually assaulted her;
- b. Mr. Ballard sexually battered her;
- c. Mr. Ballard sexually trafficked her;
- d. Mr. Ballard acted as a sexual predator towards her;
- e. Mr. Ballard caused her to feel “very uncomfortable”;
- f. Mr. Ballard made unwanted sexual advances towards her;

g. There was no actual training by Mr. Ballard and OUR being conducted at the October 2021 event (also implying no such training ever occurred).

33. All of the above statements by Ms. Davis were and are false.

34. By publishing the statements beyond just judicial filings, the statements by Ms. Davis are not subject to any privilege.

35. Ms. Davis published these statements with knowledge the statements were false, or with reckless disregard of whether they were false or not.

36. The defamatory statements made by Ms. Davis caused extreme emotional and financial harm to Mr. Ballard, and will continue to cause future damages, including medical expenses, lost income, and other special and general damages in amounts to be proven at trial.

37. At the time she made the above statements, Ms. Davis had actual knowledge that they were false, or actually entertained serious doubts as to whether they were true. Ms. Davis's conduct was willful and malicious, intentionally fraudulent, and/or manifested a knowing and reckless indifference toward, and a disregard of, the rights of others, including Mr. Ballard. Accordingly, punitive damages should be awarded against Ms. Davis in favor of Mr. Ballard.

PRAYER FOR RELIEF

Wherefor, Mr. Ballard prays for judgment against Defendant as follows:

1. For general damages according to proof;
2. For special damages according to proof;
3. For punitive damages in an amount sufficient to punish and deter Defendant and others in similar situations from engaging in such conduct in the future;
4. For costs and attorney's fees as allowed by law; and

5. For such other relief as the Court deems just and equitable.
